MDS 3.0

ADL Index/Functional Score report

This MDS 3.0 Case Mix report, previously known as the ADL Index report, has been updated to accommodate PDPM. When run by PDPM grouper, it generates a Functional Scores report that calculates scores from Section GG items and includes assessments for PPS and OBRA. When run by a RUG grouper, it produces an ADL Index Scores report that calculates scores from Section G items and includes assessments where Section G is active, which means for assessments with an ARD on or after 10/01/2023, only OSA is included.

Batch Roster report update

The Batch Roster report has been updated to display the RUG/PDPM and ADL/Functional scores.

Case Mix History report updates

On the PDPM Case Mix History report, the Functional Score calculation now includes Oral Hygiene and Walking per section GG of MDS 3.0. This report also has a Summary by Pay Type section at the end. On the RUG Case Mix Roster report, non-OSA assessments with a reference date on or after October 1, 2023, are no longer displayed because Section G is no longer used on non-OSA assessments.

Case Mix Roster report updates

On the PDPM Case Mix Roster report, the Functional Score calculation now includes Oral Hygiene and Walking per section GG of MDS 3.0. On the RUG Case Mix Roster report, non-OSA assessments with a reference date on or after 10/01/2023 are no longer displayed because Section G is no longer used on non-OSA assessments.

MDS 3.0 Assessment updates

Effective for assessments dated on or after October 1, 2024, the following changes have been made to the MDS 3.0 sections to ensure CMS compliance:

- Section GG - The Section GG title has been changed to "Functional Abilities," and column 2 for Discharge Goal has been removed from items GG0130 Self-Care and GG0170 Mobility.
- Section N - New sub-item N0415K has been added under N0415 High-Risk Drug Classes for "Anticonvulsant."
- Section O - New item O0350 has been added to indicate if the "Resident's COVID-19 vaccination is up to date."

MDS 3.0 FY2025 changes

This WellSky Long-Term Care release includes changes made to the Minimum Data Set (MDS) 3.0 in compliance with CMS's final RAI Manual version 1.19.1. When you create MDS assessments with a reference date (ARD) of October 1, 2024, or later, applicable MDS sections will contain the new changes for data element items on the form. (Assessments created with an ARD before October 1, 2024, will revert to the prior MDS version for each MDS section.)

You can access the finalized RAI Manual version 1.19.1 by selecting the "RAI 3.0 Manual" link on the MDS screen, and by selecting the "RAI Help" link within each MDS section. New changes to the manual are shown in red or yellow-highlighted text.

MDS 3.0 Import Utility

This utility has been updated to import assessments dated October 1, 2024, or later. The utility now transfers the resident's demographic information from MDS Section A to WellSky Long-Term

Care ADT, with an exception for Ethnicity, where only values A, C, and D in A1005 have a direct match with ADT values and are transferred automatically. Values B and E in A1005 have multiple possible ADT values, so you must select them manually in ADT if applicable.

Note: An imported MDS 3.0 assessment enters the WellSky Long-Term Care system as a prospect. To view an imported MDS 3.0 assessment, convert the prospect to an inpatient. This process is the same as before this update.

MDS Java PDPM Grouper FY2025 v2.3 update

Version 2.3000 of the CMS Java PDPM Grouper contains support for FY2025 ICD-10 codes which are used with MDS assessments with a target date on or after October 1, 2024. WellSky Long-Term Care has been updated to incorporate v2.3000 of the Grouper, which is used by MDS Section Z, MDS audits, and MDS Case Mix reports.

Note: If your state will start using PDPM in October 2024, you must go to the MDS 3.0 main screen > Create EDS File > Submission Information and add a record for 10/01/2024 with the STATE_PDPM_OBRA_CD set to 1 (Yes).

ICD-10 and Clinical Categories update for FY2025

The LTC7.6.5 installation automatically updates your ICD-10 Master table and Clinical Categories to reflect changes that take effect on October 1, 2024. This includes new, revised, and deleted codes, as well as the updated mapping of ICD-10 codes and MDS item I0020B to Clinical Categories. Any codes you have customized for your facility will not be overwritten.
